Instruction

- Students selecting face-to-face instruction will attend in person two consecutive days every other week and will attend virtually on all other days.
- Virtual Bell Schedule with synchronous and asynchronous instruction will continue.
- Attendance will be taken for virtual and face-to-face students each period, and can impact a student's final grade.
- Face-to-face and virtual instruction will occur simultaneously in each classroom. Students who selected to remain remote or who are not scheduled face-to-face will join the class remotely via Zoom.
- Each classroom will be equipped with a webcam and microphone to allow both face-to-face and virtual students to access instruction.
- Students attending face-to-face will physically change classes each period.

Arrival and Dismissal

- Bus transportation only available to students residential to Mount Tabor and only on assigned buses.
- Students can arrive no earlier than 8:30 a.m.
- Upon arrival, students will be screened before exiting busses or vehicles, and will report immediately to first period classes.
- Students arriving after 8:55, must report to the attendance window outside of the main office to check in and be screened.
- Students will remain in 4th period and will be dismissed by announcement. Bus riders will wait in classrooms and be called for dismissal when their bus arrives.



Safety

- All students and staff will be required to wear masks and social distance at all times on campus.
- Classrooms and common areas have been marked to maintain 6 feet of social distancing according to CDC guidance.
- Maximum classroom capacity will be 15-17 students.
- High-touch surfaces, including student desks, will be disinfected at each class change.
- Drink and snack machines and all communal areas are closed to students, including the cafeteria, Spartan Way, etc..

Nutrition

- Both breakfast and lunch will be eaten in classrooms for all students; the cafeteria is closed for dining.
- After arrival screening, students may pick up breakfast from the cafeteria and report directly to first period.
- Students who do not bring their lunch will be dismissed by classroom and escorted to the cafeteria to get lunch before returning to their classrooms to eat.
- Parents are expected to refrain from dropping off items to students during the school day such as lunches, assignments or other forgotten items. A table will be placed at the front entrance for emergency item drop offs. Mount Tabor is not responsible for any items left on this table.
- Commercial food delivery (Doordash, Jimmy Johns, parents dropping off Chick-fil-A, etc.) will be prohibited as always.
